1. Membership:

- 1.1 The membership should consist of no fewer than 5 members.
- 1.2 Where possible to include Link Governors for curriculum subjects.
- 1.3 Committee members to inform Chair of committee, Copnor Primary school office and clerk of Governors for any apologies for absences to committee meetings.
- 1.4 All committee members are expected to attend minimum of 3 meetings per annum unless prior agreement with the Chair of the committee had been arranged.

2. Quorum:

2.1 The committee shall be quorate when 3 members attend, with at least one non-staff governor.

3. Meetings:

- 3.1 The committee shall normally meet termly unless more are required to support or review curriculum and standards issues.
- 3.2 Minutes should be taken of all meetings and signed by the Chair and filed.
- 3.3 Copies of all minutes to be circulated to all Governors. Confidential minutes/notes should be sent to the Chair of the Curriculum and Standards Committee, Chair of the Whole Governing Board and Headteacher only and filed under separate cover.

4. Functions:

- 4.1 To ensure that strategies are in place to raise achievement for all pupils.
- 4.2To ensure there is high quality teaching & learning across all year groups.
- 4.3 To focus on issues arising from data concerning standards achieved in the curriculum.
- 4.4 To assist the Headteacher, SLT and teaching staff in monitoring the implementation of the National Curriculum.
- 4.5 To focus on areas of the curriculum in accordance with the School Improvement Plan.
- 4.6 To ensure there is accurate and reliable assessment and highquality tracking information for all learners across all subjects of the National Curriculum.
- 4.7To agree whole school targets (statutory and non-statutory) for attainment & progress in consultation with the Headteacher.
- 4.8To monitor progress towards these targets.
- 4.9To monitor the progress of all vulnerable learners and underperforming groups

5. General:

5.1 Any governor has the right to attend any committee meeting but without the power to vote.

6. Responsibilities of Chair of the Curriculum and Standards Committee:

- 6.1 To provide such information as required by the Auditors/ OFSTED.
- 6.2 The Chair to arrange for the EYFS Link Governor, SEN Link Governor and Pupil Premium Link Governor to carry out a termly meeting with the appropriate school representative.
- 6.3 Chair of Curriculum and Standards Committee to report and provide evidentiary support to the Chair of Governors as required on accountability and performance of the committee.
